Notice Inviting Tender

1. Percentage rate tenders are invited on behalf of Registrar, J P University, Chapra (Saran), from registered contractors of appropriate categories of State P.W.D. or similar other organizations for the *repairing and renovation of toilet (Science Block, Administrative Building, etc.) in the campus of J P University, Chapra*, of an estimated cost of Rs. 995400.00 **(Nine lakh ninety-five thousand four hundred only)**.
2. Agreement shall be drawn with the successful tenderers on the prescribed form F-2 of the Bihar Government. The tenderer shall quote their rate as per the above or below estimated cost, and the conditions of the said form, which will form part of the agreement.
3. The time allowed for carrying out the work will be 2 months from the date of issue of the work order.
4. Tender, which should always be placed in a sealed envelope, received by the authorized person up to 1:00 PM on 17.10.2025, and will be opened by a committee on 17.10.2025 at 3:00 P.M.
5. The tender shall be accompanied by earnest money of Rs. 19910.00 (Rs. Nineteen thousand nine hundred ten only) in the shape of a fixed deposit or demand draft, or NSC of any National/ Nationalized Bank /Post Office, duly pledged to the Registrar, J P University, Chapra (Saran).
6. The tenders shall be received in two envelopes. Envelope "A" shall contain the eligibility qualifications of the Contractor, such as registration of the contractor, Character Certificate, GSTIN, work experience certificate during the last three years, and the earnest money. The envelope "B" shall contain the financial bid and shall be marked on the left-hand corner of the sealed envelope. Financial Bid of only those

- contractors whose qualifications are found eligible shall be opened, and the earnest money placed in the envelope is found to be for the same.
7. Registrar, J P University, Chapra (Saran), does not bind itself to accept the lowest and any other tender and reserves the right to reject any or all of the tenders received without assigning a reason. All tenderers in which any of the prescribed conditions are not fulfilled or any condition, including that of a conditional rebate, is put forth by the tenderers shall be summarily rejected.
 8. Canvassing, whether directly or indirectly in connection with tenders is strictly prohibited, and the tenders submitted by contractors who resort to canvassing will be liable to rejection.
 9. Registrar, J P University, Chapra (Saran), reserves the right to accept the whole or any part of the tender, and the tenderers shall be bound to perform the same at the rate quoted.
 10. The tender for the works remains open for acceptance for 90 days from the date of opening of tenders. If any tenderer withdraws his tender before the said period or makes any modification in the terms and conditions of the tender which are not acceptable to the department, then the college shall, without Prejudice to any other rights or remedy, be at liberty to forfeit 50% of the said earnest money as aforesaid.
 11. You may please note that, selected for construction work, you shall have to sign an agreement on the pattern of form F-2 of the Bihar Government.
 12. Original copies of all certificates must be produced at the time of signing of offers for verification of certificates.
 13. This notice inviting tender shall form a part of the contract document. The successful tenderer/Contractor, on acceptance of his/her tender by the accepting authority, shall, within 7 days from the stipulated date of start of work, sign the contract consisting of A, Form F-2 of the Bihar Government.
