Notification

On the recommendation of Bihar State University Service Commission, Patna under the provisions contained in the Statutes duly approved by the Chancellor of the Universities of Bihar vide notification memo no.-BSU(Statute)-14/2023-647/GS(I) dated-03.05.2024 for the appointment of Principals in the Constituent Colleges of Jai Prakash University, Chapra governed by the Bihar State Universities Act, 1976 (as amended up-todate) and communicated by Higher Education, Education Department, Government of Bihar vide its letter no. 15/₹ 2-04/2025-2014 dated-24.04.2025, the following named candidates are appointed as Principal with their details as under:-

- The tenure of appointment will be for a period of Five years from the date of Joining subject to the condition of the age of retirement (65 years whichever is the earlier). The Scale of Pay of the Principals appointed under the provisions of the Statutes shall follow the notification by the State Government, Bihar from time to time with all admissible allowances as per the provisions of the Bihar State Universities Act, 1976 and Statutes.
- The above-named selected candidates will submit their joining within 03 months from the date of notification.
- The selected candidates are required to submit his/her relieving Certificate and NOC in original from his/her employer along with joining letter.
- During the course of employment in the Jai Prakash University, Chapra if any of the Certificate/Documents submitted by any of the candidates is found fake/tempered, the appointment of that candidate is liable to be cancelled and a legal proceeding shall be initiated against the candidate.
- The selected candidates will be governed by the Bihar State Universities Act,1976 (as amended up-todate) and statutes and have to abide by the service rules of the Bihar State Universities.
- A College Principal shall be appointed for a period of five years, extendable for another term of five years on the basis of performance.
- After Completion of his/her term as Principal the incumbent may join back to his/her parent organization.
- The selected candidates also have to submit a declaration from the 1st class Judicial Magistrate in the format attached herewith at the time of joining.

No. T.A./D.A. shall be paid for joining the post.
